TERMS AND CONDITIONS OF ENTRY

1. The artist must be a resident of South Australia.
2. The sitter must be a living resident of South Australia, and have a minimum of one sitting with the artist.
3. Maximum of **three** entries per artist
4. The portraits must be:
 - an original work, created and owned by the submitting artist
 - completed within the last 12 months
 - in oil, acrylic, pastel or mixed media; a drawing, original print, photograph or sculpture;
 - completely dry, suitably presented (eg. sides of a stretched canvas painted or clean white) and ready to hang with 'D' rings or display in a condition which is safe to handle
 - **For 2D entries: up to** 70cm wide - \$20 (members) \$25 (non-members), up to 100cm wide - \$30 (members) \$35 (non-members), 100cm to 150cm wide - \$35 (members) \$40 (non-members)
 - **OR For 3D entries:** \$20 (members), \$25 (non-members), max weight 20kgs.
5. The judges and organisers reserve the right to declare ineligible any work that does not conform to their interpretation of the terms and conditions of entry.
6. All art works **must** be for sale with 30% commission received by RSASA.
7. The first prize is **acquisitive**, and the winning portrait immediately becomes the property of the Kennedy Arts Foundation.
8. The judges have absolute discretion in selecting the Finalists and Winner and judges' decision will be final and not subject to discussion or appeal and no correspondence will be entered in to.

HOW TO ENTER

9. Entrants must complete the entry form available by downloading from www.rsasarts.com.au/portrait-prize/
10. Each completed entry form and image must be submitted via email (preferred) to exhibitions@rsasarts.com.au or post, no later than Thursday 30th May 2019 at 4.30pm Australian Central Standard Time together with: payment of the non-refundable relevant entry fee inclusive of GST digital **or** A4 image of the work. In order to ensure your sitter is aware of your entry to this competition see the sitters statement at the end of the entry form.
11. An entry form will NOT be considered to be received, until payment of the entry fee is received by the RSASA.
12. No responsibility is accepted for late, lost or misdirected entries.
13. Entry fee is payable with cash, cheque, money order, credit card details on entry form **OR** direct deposit, cheque/money order payable to **Royal South Australian Society of Arts**.

14. **Digital images** (preferred) must be: jpg format; of a resolution of no less than 300dpi; less than 3000x3000 pixels per image; not of a file size exceeding five (5) megabytes each; named in the following: artist's name, title of portrait, sitter's name, medium.
15. **A4 images** must be: a high-resolution quality print; named in the following way on the back: artist's name, title of portrait, sitter's name, medium mailed to: **Royal South Australian Society of Arts, PO Box 177 Rundle Mall, Adelaide 5000**

DELIVERY OF WORK

Artists whose work has been selected can deliver work to the RSASA Gallery, Institute Building, (1st Floor) corner North Tce & Kintore Ave Adelaide SA 5000 on: **Tuesday 23rd July between 10.30am and 4.30pm.**

There are 2 loading zones for drop-off of art work on Kintore Avenue that might be available to be used. To discuss delivery by courier or to arrange another convenient time for delivery please call: **8232 0450** on Tuesdays and Thursdays between 10.30am and 4.30 pm.

Label on work: labels with the artist's name, title of work, medium and price must be attached to the back of each work AND on any packaging for easy identification, which will be supplied by RSASA after round 1 judging.

COLLECTION OF WORK

Last day of the Exhibition is Sunday 25th August 2019. Works not sold can be collected at the cost of the artist on Monday 26th August between 10.30am and 4pm. Artists whose works are sold will be notified beforehand.

JUDGING

In order to ensure an exhibition with a high standard of work, judging will happen in two stages by a panel of three judges.

SEMI-FINALISTS- Judges will make an initial semi-finalist selection from jpeg and A4 images. Artists whose works have been chosen as semi-finalists will be notified by email or telephone of their success and are required to deliver their works for further judging to the RSASA Gallery, either in person or by courier on Monday or **Tuesday 23rd July 2019 between 10.30am - 4.30pm**

All semi-finalist artists are advised to insure their works against loss or damage for the 2019 RSASA / SALA Portrait Prize competition during periods of travelling, handling, judging, exhibition and storage. All reasonable care is taken with all entries, but Royal South Australian Society of Arts takes no responsibility whatsoever for loss or damage however caused to any works submitted.

FINALISTS - Judges will then **select finalists and choose prize winners by viewing actual work.**

Non-finalist will be notified, their work held 'in reserve' and can be collected at the exhibition's conclusion at the cost of the artist.

Artists of selected works will be notified in June 2019

ANNOUNCEMENT OF PRIZE WINNERS

The First Prize Winner of \$10,000 and other prize winners, will be announced publicly at the opening of the 2019 RSASA Portrait Prize exhibition on Sunday 28th July, 2pm at the RSASA Gallery, Institute Building (1st Floor) corner North Tce & Kintore Ave Adelaide SA 5000
